Executive Summary

The Commission is pursuing the strategy on Open Access to Scientific Publications and Research Data. In Horizon 2020 each project should implement this strategy and make the results of their research available to the scientific community. Dreams4Cars is fully committed to this strategy and is prepared to organise the collection, storage and curation of research data generated during the project. This will be organised and implemented through the Data Management Plan (DMP).

This deliverable provides the Dreams4Cars data management plan Version 2 (update).
